

# REQUEST FOR PROPOSAL FOR THE ARCHITECTURAL DESIGN AND ANCILLARY CONSULTING SERVICES FOR THE DEVELOPMENT OF THE PROPOSED AFRICA RE OFFICE BUILDING AT MEGENAGNA, ADDIS ABABA, ETHIOPIA

#### 1.0 BRIEF

The African Reinsurance Corporation, Africa Re is an international organization with Headquarters in Lagos, Nigeria. Africa Re has six regional offices in Abidjan (Ivory Coast), Cairo (Egypt), Casablanca (Morocco), Lagos (Nigeria), Nairobi (Kenya), and Port Louis (Mauritius). In addition, Africa Re wholly-owns a Subsidiary in South Africa and a Retakaful company in Egypt. The Corporation is owned by 41 member states of the African Union (AU), the African Development Bank (AfDB), 111 African insurance and reinsurance companies in Africa and 3 leading global insurance and reinsurance groups.

## 2.0 INTRODUCTION

Africa Re is in the process of developing its Contact office Building in the Megenagna neighborhood in Addis Ababa, Ethiopia

The project being contemplated will be high rise office building with first class facilities and meeting standards that will ensure maximum return on investment.

#### **SCOPE OF WORK**

The role of the participating consortium of Architectural & Engineering firm is to present design concepts for a high rise office building of ten (10) floors with emphasis on open floor design concept and guided by the brief below:

The above list of space requirements is indicative only. The architectural design should be more accurate and proactive through the architect's own knowledge in modern office management and discussions with Africa-Re to assess its current and future needs.

The submission should include:

- 1. One or more architectural design proposal (s)
- 2. A feasibility study which amongst other details will advise on::
  - Expected rental income
  - Estimated payback period
  - Average running cost

# **CONDITIONS FOR ELIGIBILITY**

Invited architectural consulting firms are required to have in its organization Project managers, service and structural engineers.

The firms are also to submit pre-qualification documents detailing their company's capabilities, evidence of registration with relevant professional bodies in Ethiopia, cognate experience of practicing firm's partners and proven experience in modern office building design.

In addition to the eligibility conditions above, the submissions must be accompanied with the following:

- Evidence of Company Registration with the relevant authorities in Ethiopia
- The Company's audited accounts for the last three years (2016-2018).
- Evidence of financial capability
- Evidence of having successfully carried out similar design works within the last five years.
- Comprehensive company profile and organizational structure.
- Resumes of key technical staff to be deployed
- Evidence of availability of requisite and appropriate staff/skill for job.
- In case of an international firm, evidence of local partnership.


